Street Improvements - Maltene Application

Public Works Maintenance Jason Styve presented information regarding the installation of maltene on selected roads. In 2021, the City had maltene applied to several roads within the City. These roads have held up well and Public Works would like to continue the use of this product.

High Street Pedestrian Crossing

Engineer Steve Heglund stated the Council authorized Stantec to obtain quotes for the pedestrian improvements at High Street and Elm Street. The pedestrian improvements include new ADA compliant pedestrian landings and a Rectangular Rapid Flashing Beacon (RRFB). Stantec is also working with Wright County SHIP grant program for cost participation opportunities for this project. If the City receives this grant, that agreement will be brought to Council at a later date.

Motion was made by Hafften and seconded by Michalik to award the quotes for the project to Blackstone Contractors, LLC for the amount of \$75,597.96 with funding to be determined at a later date.

Staff Reports

Members of Staff and Council then discussed various City updates including: City Administrator Anna Carlson is working on funding for a waste water project, a proposed heritage center and Rocktoberfest. Public Works Maintenance Jason Styve stated that hydrant flushing will be April 4th, 2024. Heather Michalik stated that the Masons Hog Roast is April 6th at Rockford Township Hall, April 20th is the Expo at Rockford Community Center. Mayor Renee Hafften Stated Clean up day is May 4th and the Fire Department pancake breakfast is May 5th.

Open Forum

Daniel Sarkinen stated his concern is in regard to the stop sign change at Walnut and High St. He wants people to stop at the top of the hill to slow them down. His request is that Council revisit the intersection to see if it can be made safer. Mayor Renee Hafften stated the change is because the Northwest corner was never traffic controlled and the bus loading and unloading prompted that reevaluation. Mr. Sarkinen would like a stop sign for Eastbound traffic on Walnut. Mayor Renee Hafften stated that this item will be revisited at a future meeting.
